Please review the following information thoroughly. Please note: This is a binding contract.

This agreement is between _____ and Austin's Elite & One Eyed Odin.

Payments: In lieu of deposit, all events require a credit card on file. We will not run aforementioned credit card unless payment is not received by agreed upon date, or in the event damages caused by _____. All payments are due day of the event for permits. Final payment is due day of your event.

Sales: Bar sales much reach \$1700.00 in sales, and each bartender must receive \$200.00 in gratuity. If this is not met, the difference will be billed at the end of the event.

Cancellations: This is a rain or shine event. Weather is not reason for cancellation. All permits are non-refundable. If event is cancelled within 5 days of _____, 50% of the required bar sales will be due in addition to permit fees.

Late Payments: If final balance is not paid by the the aforementioned due date, we will run the card on file and send you a receipt by email. There will be a \$50 per day late fee added to invoice for every day past due date until payment in full is received.

Clauses:

- NO OUTSIDE BEVERAGES ALLOWED. All beverages must be sold by the bar. This includes non-alcoholic beverages. Absolutely no complimentary drinks at the event.

- IDs are required to be served adult beverages—everyone must have a valid ID and be at least 21 years of age. No alcohol allowed outside of the controlled areas.

- Event host must provide experienced security personnel to check all attendees' entrance to ensure no drinks come in or out.

- Client is responsible for any and all permits needed, and payment is required in full the morning of the event for the permits.

- Neither the client nor anyone representing/hosting the event is allowed to request or knowingly ask service providers to serve liquor to minors. Staff reserves the right to refuse service to anyone. Our staff is required to follow all TABC laws and regulations. Our staff will attempt to verbally notify the client and/or a responsible party if they witness an intoxicated person or disturbance. It is not our policy to handle such cases.

- We carry a four (4) million dollar limited liability insurance policy and liquor liability insurance to cover event incidentals. If individuals other than our TABC certified staff members are found to be serving alcohol, or if alcohol service continues after our staff has vacated the event, the insurance policy will be nullified and we are not liable.

Lost Items: Austin's Elite & One Eyed Odin are not responsible for items lost, stolen, or left behind at venue.

Termination: This Contract shall remain in effect until either party terminates this Contract with 30 days written notice and it is acknowledged by both signees.
